It has been observed in 1988 that about 35, 000 children are paralyzed due to polio<sup>1-2</sup>. Betterment was seen in 2016 when only 50 cases of polio were observed. In the meantime, only 3 states were left with the presence of polio virus. The initiative to eliminate polio from the world has been working in about 60 countries<sup>3</sup>. Each year 2.2 billion medicines of polio have been given to about 430 million children. In some state's polio is transferred from other countries.

GPEI provides tools and functions recently. Many personnel, volunteers, skilled employees at restricted, provincial and international levels are added in this funding<sup>4</sup>. It also includes 146 labs of polio. Population has been activated and assembled by these international communications. It distributed towering excellence interferences and masse; assembled monetary, opinionated, and communal prop up; reacted to disorder eruptions and sustained humatarian urgent situations<sup>5</sup>. GPEI is also working in other functions like security services and disorder that can be protected by immunization<sup>6</sup>. Many important risks are also present. 
## MATERIAL AND METHODS:

5 organizations are working for the help of GPEI. These are the Center for Disease Control and Prevention, Bill and Melinda Gates Foundation, Rotary International, The United States Children's Fund and The World Health Organization. Each of

these organizations is functioning in the elimination of the polio form the world. These organizations have a strong harmonization with each other. Mainstream of employees are under the working of World Health Organization and United Nations Children's Fund. view of the functioning of each agency of the GPEI. Some progression was seen at the end of 2016 but the rate was different in different countries.
